**Report of the Secretary placed in the Annual General Body Meeting held  
on 8.8.2015 at Chennai.**

*Dear friends,*

The proposal to form a Welfare Trust was informally discussed in the meeting held on 7.1.2007 which was attended by all Ex-Circle Secretary's of AFSOA and Diary Conveners. The Ex-Circle Secretary meeting decided to convene a combined executive committee meeting of AFSOA of TN Circle and Chennai Telecom District, for taking further follow-up action. Accordingly a combined, EC meeting of AFSOA was held on 25.03.2007 at AFSOA house and it passed an unanimous resolution to form a Trust called "**Tamil Nadu Telecom Accounts and Finance Officers Welfare Trust**" and the transfer of the Asset of AFSOA to the Trust. The combined EC of AFSOA also elected 15 Trustees to draft the Trust Deed and for its registration.

The trustees viz., V. Sivasamy, S. Dakshinamoorthy, P.Santhakumar, & K.Balasubramanian were entrusted with the work of consulting a lawyer & finalise the draft. The draft proposal of Trust Deed was approved by the Trustees in the meeting held on 21.4.2013 and finally the Trust Deed was registered in the Sub Register Office, Kodambakkam on 10.02.2014. Shri V.Sivasamy devoted most of his time and energy, with the result the Trust deed was successfully registered. The services rendered by Shri. V. Sivasamy, Managing Trustee deserves appreciation from one and all and his service will be placed on record.

After Registration of Trust Deed the first meeting of Trustees was held on 16.3.2014 and it was decided to enroll large number of members to carryout the charitable activities as listed in the Trust Deed. The 2<sup>nd</sup> Meeting of Trustees was held on 10.08.2014 and in the Meeting Shri.K.Rajaram, & R.R. Ramasubramanian were elected as Joint Secretary and Shri. S.G. Jayaprakash as Assistant Treasurer.

In connection with enrolment of members, S/s V.Sivasamy, S.G.Jayaprakash, K.Rajaram, KBS & Sathyamoorthy visited various Officers in Chief Telephone & Circle Office, TN Circle on more than 3,4 occasions Due to the efforts of Shri. C.Duraiarasan, Add. Managing Trustee a large number of

members for TNJ SSA joined as life members. Shri Sivakumar, Senior AO, STR played a major role in enrolling a large number of members from Maintenance Region. Shri. Ramasubramanian, was instrumental in enrolling large number of retired people from Madurai Area.

VPS in this regard.


Shri S.Dakshinamoorthy, Trustee, addressed all Retd. Accounts Personal enclosing copy of our appeal and membership form. Due to his sustained efforts large number of ret'd. account personal enrolled as members. The effort made by Shri. Dakshinamoorthy, deserve appreciation from one and all.

Shri. V.Sivasamy, K.Rajaram, C.Duraiarasan, S.Dakshinamoorthy, R.R. Ramasubramanian and K. Balasubramanian visited Madurai on 29.07.2015.

Trust meeting was also held on 8.2.2015 and 17.5.2015 to review the progress of enrollment of members. In the meeting held on 17.05.2015 it was informed that more than 100 has joined as members of Trust and hence decided to convene a general body meeting in the first week of August 2015.

**Conclusion:** Through lot of efforts have been made, we could not register the trust in time, we regret very much for the delay in registration of the Trust Deed, due to various reason. But now, the formation of Trust has become a reality, we appeal to all concerned to join in large number to successfully carryout the charitable activities, lighted in the Trust Deed to bring laurels to the name of Telecom Accounting & Finance Service Officers.
