All the eligible accounts personnel at Vellore who were yet to join the trust are being enrolled on this occasion by the active Vellore members, Shri Arumugam informed.

Presidential address:

Managing Trustee, in his presidential address again thanked the Vellore members for making excellent arrangements for the meeting at Vellore in a grand manner. Congratulating the Vellore members for their enthusiasm in ensuring enrolment of every F&A person in the trust, the Managing Trustee narrated the journey of the trust and challenges faced to reach the level of over 400 plus members in a span of eight years from 2014, for the benefit of new members present. He also recollected the timely advice and guidance from our stalwart leader Late Shri K.S. Jayavelu in augmenting the Corpus fund through the sale of our AFSOA house at Kodambakkam and in legal formation of our Trust, hardly with 25 founder members. The activities after the trust registration, membership mobilization etc. in 2015-17 were somewhat in slow phase as most of our active trustees

were in service and could not spend quality time. After this, we started growing in leaps and bounds. We regularly started having meetings, and even during the two years of Corona pandemic, we conducted tele-meetings. Our Coordinators who braved the pandemic and distributed the cash awards and meritorious certificate to the students in person need to be congratulated, he said. To manage information dissemination, we started WhatsApp group and created a website.

We have witnessed a stupendous growth of almost eight times in terms of money distributed and ten times in the number of students covered in a span of five years with whole hearted support of the members. He presented the yearwise facts and figures for the benefit of the members:

In the year 2022, we included more rural and remote Government Schools, carefully selected by 24 of our active members after a lot of careful due diligence, he mentioned. He thanked the coordinators for being in the field and straining hard for circulating the information, collection of data, distribution of financial assistance and meritorious certificates in person to the students. Shri K. Raajaram and Shri S. Sethu did the consolidation of data, preparing the certificates disbursement of amount etc. in tandem. He informed the members that all the work was done on voluntary and honorary basis, and many of the coordinators spent sizeable amounts from their own pockets to complete the project.

We donated Rs. 6.75 lakhs to the Central Government and TN / Pondy State Governments

A whopping amount of Rs. 41 lakhs was received from the members / donors so far in the past 7 years and more than Rs. 40 lakhs has been distributed to really deserving cases, including NGOs engaged in charitable and upliftment activities. In the last 7 years, 105 NGOs have been extended financial assistance by our trust. The Managing Trustee added that we ensured that keeping of funds idle has been carefully ensured. He cited an example of the generosity of our members in raising to the cause, to help poor family of a deceased casual labour Shri Suresh of BSNL. Rs. 1.3 lakhs was sent in by our members in a span of ten days in this case! Our members are regularly donating during the occasions like birthday, wedding day in their family, he recalled. It is heartening that some of the family members of our trust members also donate regularly, he said.

He welcomed advice for improvement in the trust activities from our members. He extended warm greetings to the newly inducted nine members. A small cadre in DoT / BSNL is making a big difference in serving the society, he opined.

The Managing Trustee concluded his presidential address extending special thanks to Shri K. Raajaram who maintains the trust website which paves way for complete transparency.

The main items of the agenda were taken up next.

Secretary's Interim report:

Following are the excerpts from the interim report of the Secretary:

Meritorious certificate & Financial assistance to +2 toppers: A total of 401 Government school students (277 Girl students & 124 boys) studied in 132 rural & remote area schools covering 22 districts were completed by August 2022, except one school, which is slated for completion soon. 24 of our trust members have coordinated in this task. Shri S. Sethu and Shri K. Raajaram managed the overall coordination. Rs. 8.01 lakhs has been distributed to the topper students. The events were well covered in local media too and news items were published in local newspapers in Pattukottai, Dharmapuri, Karaikudi and in some other places. The board of trustees places on record the yeomen services of coordinators and Shri P. Santhakumar for the successful completion of this project.

Membership: Total number of members as on date in our trust is 410. Since last meeting 11 new members have been enrolled.

Corpus fund: Total Corpus fund of our trust as on date is Rs. 37 lakhs available in PNB and Indian Bank in the form of FDs of Rs. 27 Lakhs Rs. 10 lakhs.

The following Charitable activities done since last meeting:

- 1. Viduthalai welfare trust Rs.10000/- paid on 21.07.2022
- 2. Kaaviya B.Sc.(Trauma care) Financial assistance Rs.10000/- paid on 8.8.2022 This is the third consecutive year
- 3. Deepam Trust: Rs.10000 paid on 11.08.2022
- 4. Dheenabandu Ashram Walajapet Rs.10000 paid on 25.08.2022
- 5. Narikoravar Educational trust Rs.20000/- & Rs.21000/- paid on 18th and 21st October 2022
- 6. Financial assistance to late Suresh family CDL Rs.5000/- paid on 15.11.2022
- 7. Educational assistance to S. Balamurugan B.Sc. IT Rs.7000/- on 15.11.2022

For all the above cases approval received from the trustees and special invitees through WhatsApp group messages and payments were made on the dates noted against each.

Special drive: An appeal was made by our Managing Trustee for the (Late) Suresh excasual labour in BSNL. 55 members have contributed a sum of Rs. 1.29 lakhs till the date of meeting. The modalities of making the payment to the family may be decided in the meeting. After discussion it is decided that as per the request of the Wife of Late Suresh the amount will be paid by way of Fixed Deposit receipt.

Our trust account for the financial year 2021-22 has been finalised and sent to the Auditor on 5.10.2022. We are pursuing to get it audited at the earliest. 80 G exemption application will be made after audit & filing the return.

Secretary thanked **Shri K.S. Manoharan** our senior member who has sponsored breakfast to the members & special invitees came from Chennai.

Discussion regarding Educational Assistance to Meritorious students / Toppers studying ITI / Polytechnic courses in Government Institutions:

This has been discussed in depth by the trustees & special invitees. As per the input given by Shri C.P. Ravikumar and others regarding Government stipend / support to ITI / Polytechnic students the proposal is at present deferred.

Discussion regarding granting of Educational Scholarships to poorest among poor students studying X, XI and XII std. in Government Schools:

The Scholarship will be given on the basis of family situation and economic status of the students studying in X, XI and XII to encourage them in their academic pursuits. The amount of scholarship will be Rs.1500/-per student per year. This proposal was discussed at length by the trustees and special invitees. Some members mentioned the difficulty in identifying the right person as the feedback / report from some school authorities are not encouraging. MT & Secretary replied that our coordinators have to overrule the obstacles

and shared their experience too in such cases. It is unanimously decided by the trustees and the special invitees that Rs.1.5 lakhs for this year will be allotted for this specific purpose. Trustees' committee will decide the proposal application form.

Financial Assistance to +2 toppers Year 2023:

Government has announced that the Higher Secondary Examination will be held in the 2nd week of March 2023. As such our letter indicating the proposal to honour the meritorious students are to be delivered to HMs in the first week of January 2023. We will call for volunteers and complete the process before December 2022 and will follow last year procedure.

Finance secretary report on the status of funds:

Shri P. Mohan FS read the report for the information of the trustees.

Donation to NGOs. New Cases for consideration and approval:

New proposals for discussion and approval of the trustees & Special invitees:

- a) Ray of Life Foundation (Cancer care for children) started in 2002 and taking care of around 200 children.
- b) Sevalaya
- c) Anbagam rehabilitation centre
- d) Thilliambur home for the aged (150 inmates)
- e) Manithaneya Unavagam (NLC Dindivanam Poovaragan)
- f) Sharada Ashram Ulundurpet
- g) West Mambalam school for providing snacks to 11th and 12th class students who are attending special classes after school hours
- h) All the children (Home for Orphanage boys)

The above proposals were discussed by the trustees. Rs.10000/- has been approved for the cases (a) to (g) each and Rs. 5000/- was approved for (h).

Any other item with the permission of the Chair:

Trustee **Shri. C. Sathiamurthy** sought for clarification/status on three items, which are indicated below together with the response from the Secretary:

80 G Exemption: It is clarified by the Secretary that the after completion of accounts and auditing for the last year and submission of IT return, we can initiate the process. Preliminary discussion has been completed with the Audit firm in this regard.

Capital gain tax refund: It was clarified by **Shri C. Duraiarasan** that due to non-availability of PAN no. for TN AFSOA the capital gains tax could not be paid in the name of AFSOA. Hence it was paid through the then TN Secretary AFSOA. After discussion, it was stated that the concerned year IT return of Secretary AFSOA will be made available to the MT/Secretary for information. It was stated by the then Secretary AFSOA TN Shri Duraiarasan that *prima facie* no refund was eligible owing to the fact that he had to show matching income to set off the capital gains tax paid. He confirmed that no refund was received by him from the income tax department. He agreed to provide copies of the income tax returns for the concerned years to corroborate his statement to the welfare trust for record purposes.

Corpus fund and matching FDs: Secretary clarified that all the amounts received towards corpus fund so far has been converted into Fixed deposit in PNB. Rs. 84,500 is available at bank and FD will be taken after it crosses one lakh.
